Administration met with the community police to understand why Westpark does not qualify for a crossing guard and further police

support. They gather information regarding the number of walkers, regular vehicle traffic, number of options available, presence of children without adult support and number of intersections. A crossing guard is guaranteed a minimal number of hours per day, and it is already exceptional that Westpark Blvd has 2 crossing indications with lights. Since parent traffic is not part of the consideration, our school community does not even come close for consideration. For over 15 years there has been countless school administration and police interventions and parent communications with little to no change. The priority of staff supervision on Howard is the safety of our students on school property and not to manage the poor behavior of parents who refuse to follow the drop off procedures.
