8. LBPSB Parents' Committee

8.1. Roles and functions of the Parents' Committee

At each school, 2 parents from the governing board are elected as the delegate and alternate delegate to represent all parents of the school. The Parent's Committee is an advisory and consultative body of delegates from every school within the school board. The role of the parents' committee is to ensure that the parents' needs and advice are communicated to the Council of Commissioners and to the board's administration, with delegates representing all parents at the school and not just the governing board. The delegate for 2020-21 was Alaina Charszan. The alternate delegate for 2020-21 was Michelle Sternszus. PC members attend a minimum of 3 meetings per month with additional meetings for those members elected to the advisory and to the school board's subcommittees. The PC is also very active in training GB members and chairs as well as in planning presentations for the board's parent community at large.

The PC remained very active during the pandemic. 9. Home & School Presentation

Despite the challenges and restrictions, Home & School had yet another very successful year. The ongoing fundraisers of Jadon uniform sales, FundScrip, and Lovable Labels continued, and we were able to bring back Pizza Lunch towards the end of the year, which was very successful. With the help of a grant from the school board, we saw the school yard revamping project through completion with the installation of the 2 new play structures. We started the year with the school kit sale, and we gave all homeroom teachers allocations for classroom supplies, and over the year, we fulfilled many requests from wish lists. We provided funds for the science and music programs. We held another virtual Bingo night, and we introduced a limited-time-only tie-dye Westpark hoodie. We provided ice cream pops and popcorn treats for all students and staff in the last week of school.

10. Formation of a Parent Participation Organization (PPO)

Westpark has not had a PPO since 2016, when its activities were minimal because of the vibrance of our H&S, our leadership team, and the initiatives of teachers and support staff. Our school has been very successful at adding so much to the school culture and to our children's academic experience, in the absence of the PPO. It is added that most schools do not have both Home & School and PPO committees. With Westpark having a very strong Home & School, it would be to its

detriment to have both committees running simultaneously, in terms of the requests made of the community, the volunteers needed, and the time and participation of the school's administration. No PPO formed (vote was cast), no election for chair is called.
